#### WHAT IS ASECAP?

ASECAP is the only European professional association of tolled motorways companies.

#### **ASECAP**

- Defends the toll system as the most efficient and reliable way to finance and develop road infrastructures

# **ASECAP** is in permanent contact with the European Union institutions

Through the experience of its members, ASECAP supports the EU in its policy to finance, operate and develop the European Road Networks. The Association participates in the EU debate for a sustainable transport policy.

ASECAP has issued position papers on the electronic road toll system, on tunnel safety and on transport charging.

#### **ASECAP** is active in the enlarged Europe

ASECAP is present in central and eastern European countries and intends to anticipate the impact of Enlargement. The Association has signed a Memorandum of Understanding with the United Nations Economic Commission for Europe (UNECE).

ASECAP and UNECE co-operate on the Trans-European North South Motorway project.

# **ASECAP** takes part in various research and development projects

Led by ASECAP, the MOVE-it project defined functional specifications for a European non-stop tolling system. Today ASECAP is in charge of the EU multi-phased CESARE project.

CESARE aims to develop an harmonised electronic tolling system to be used all over Europe.

#### **HOW DO WE WORK?**

- The General Assembly and the Steering Committee are the policy-making bodies of ASECAP.
- ASECAP Permanent Committees (COPER I on the tolling and charging regimes, and COPER II on environmental and safety issues) examine the political, economic and operational factors which need to be analysed
- Task forces and ad hoc working groups are created where appropriate.

ASECAP has also established, in co-operation with the European Commission, an informal and consultative body, the **Road Platform**, whose aim is to analyse the key elements of the transport sector, such as road safety, infrastructure management, road charging methodologies, environmental and social costs, ITS standardisation, etc.

#### Protect the environment and promote a sustainable motorway transport network

Toll motorways are the most adequate system to monitor the traffic and at the same time, protect the environment effectively.

#### **ASECAP BY ITS PRESIDENT**

ASECAP is the unique association of toll road operators and intends to promote an exchange of experiences and know-how, allowing its members to benefit from the experiences of the countries that have been developing a "toll culture" for many years.

ASECAP is an association definitely focused on Europe and wishes to play a leading role in the development of a harmonised Trans-European network.

As new charging systems emerge (especially in Germany, the Netherlands and Great Britain), the ASECAP members have to pursue their action and studies on that matter in order to find a way to achieve the interoperability of systems based on different technologies.

This aim is clearly identified in the ASECAP members' participation in the multi-phased CESARE project, co-financed by the European Commission and whose aim is to develop a common electronic tolling system to all members that could be used by other countries of the European Union.

#### Rémy Chardon, President of ASECAP

Graduate from the *Institut d'Études Politiques de Paris*, former student of ENA, Rémy Chardon started his career in the prefectoral function and he was in charge of high level responsabilities within the territorial administration and the ministerial cabinets.

In particular he was Counsellor of the Prime Minister in 1986 (Mr. Jacques Chirac) and 1995 (Mr. Alain Juppé) and Head of Cabinet of the Paris Mayor, Mr. Jacques Chirac, from 1993 till 1995.

He has been President of Autoroutes et Tunnel du Mont Blanc and of Société des Autoroutes Paris – Normandie. He is President of SAPRR (Société des Autoroutes Paris-Rhin-Rhône) and ASFA (Association des Sociétés Françaises d'Autoroutes et d'Ouvrages à Péage) and Director of the Board of IBTTA (International Bridge, Tunnel and Turnpike Association).
